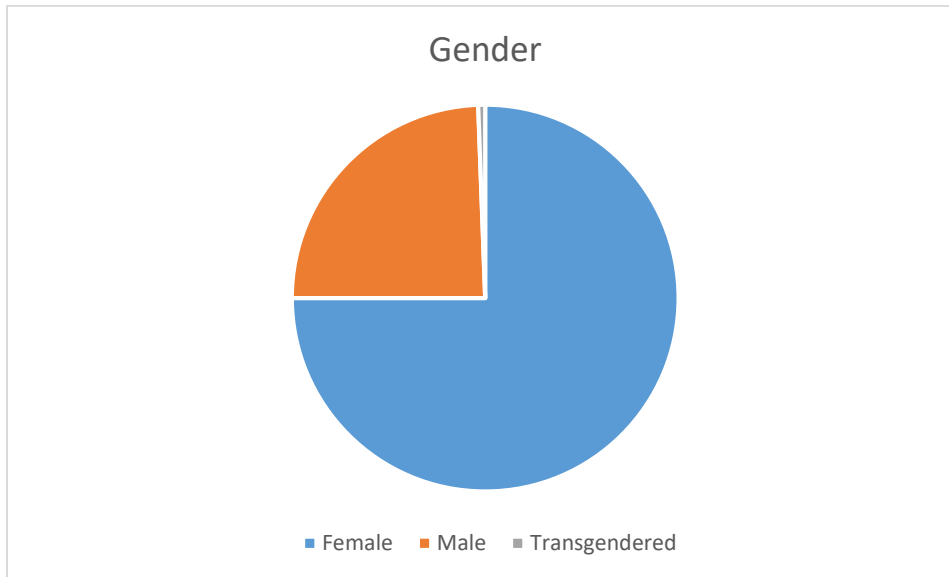


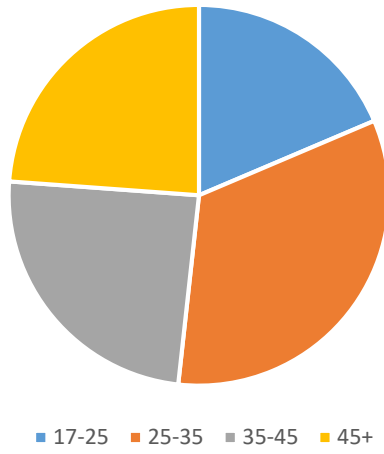


SEXUAL ASSAULT CLIMATE SURVEY

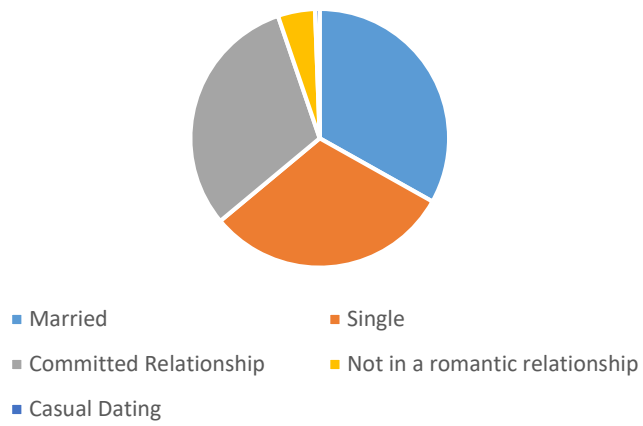

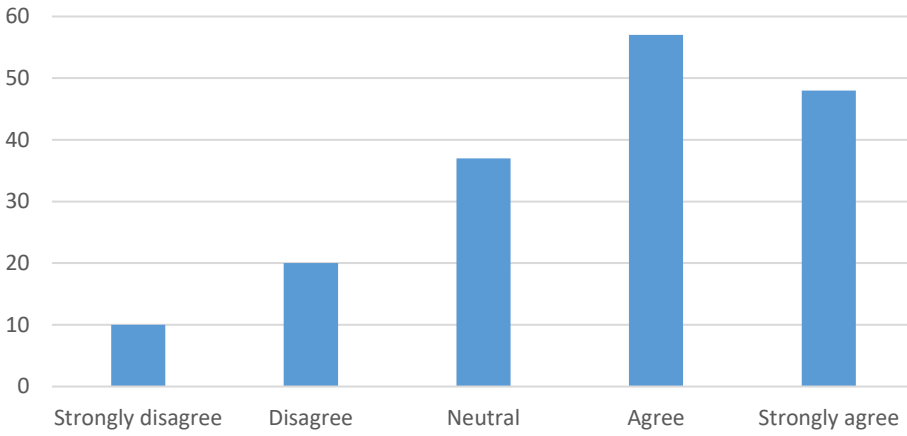
Current relationship status



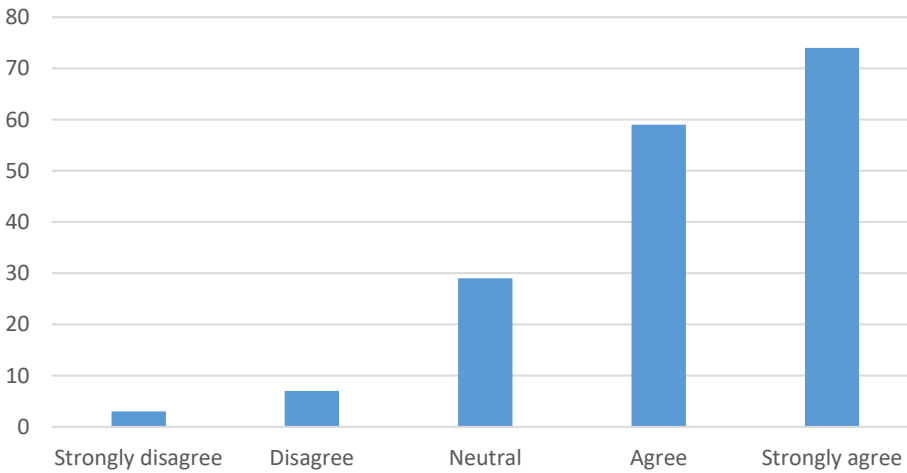

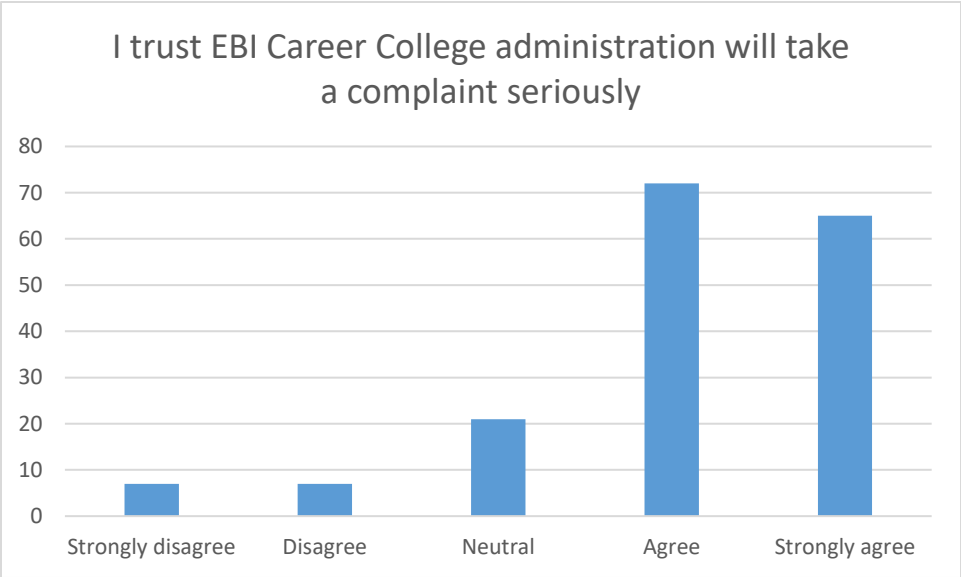

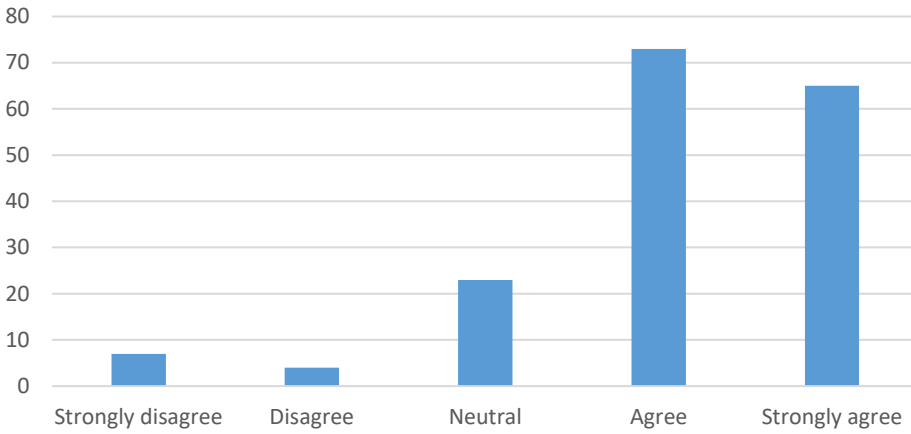




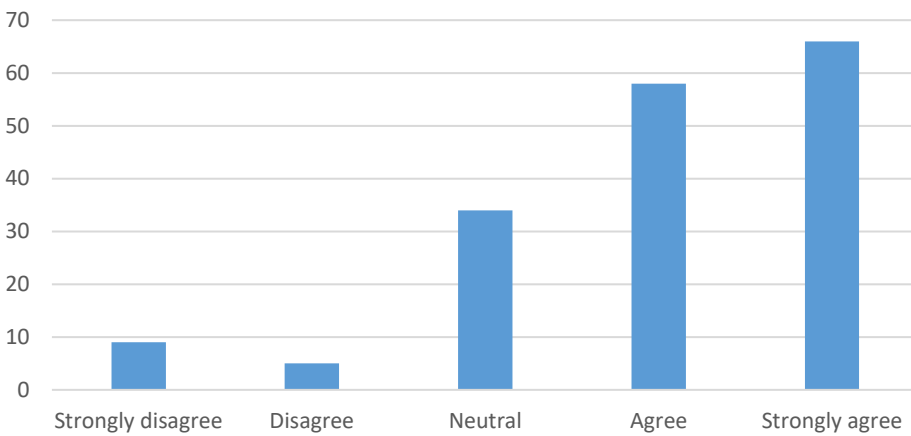
Student Perspectives on Elmira Business Institute’s Handling of Complaints of Sexual Violence or Harassment



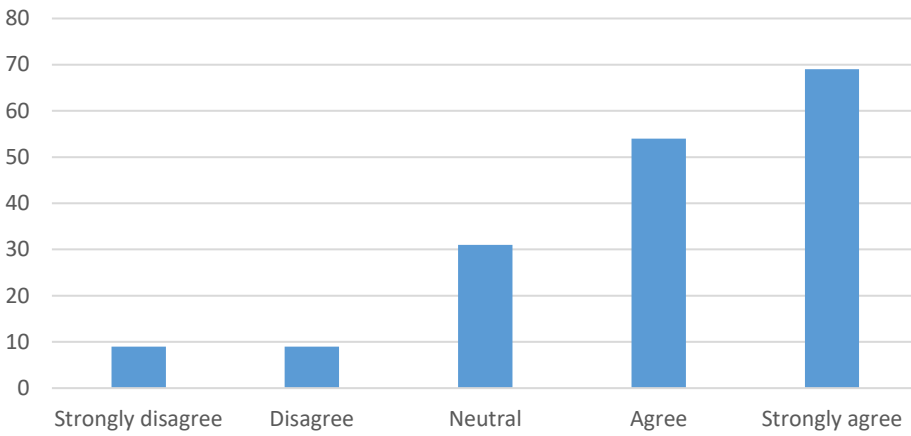

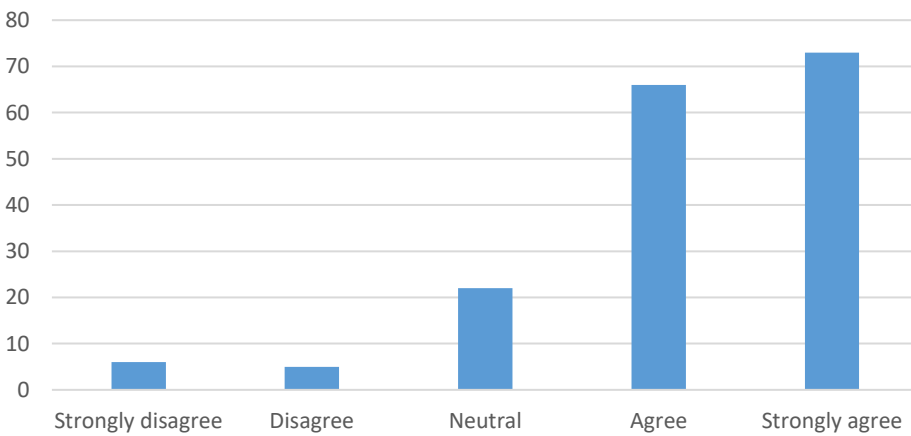

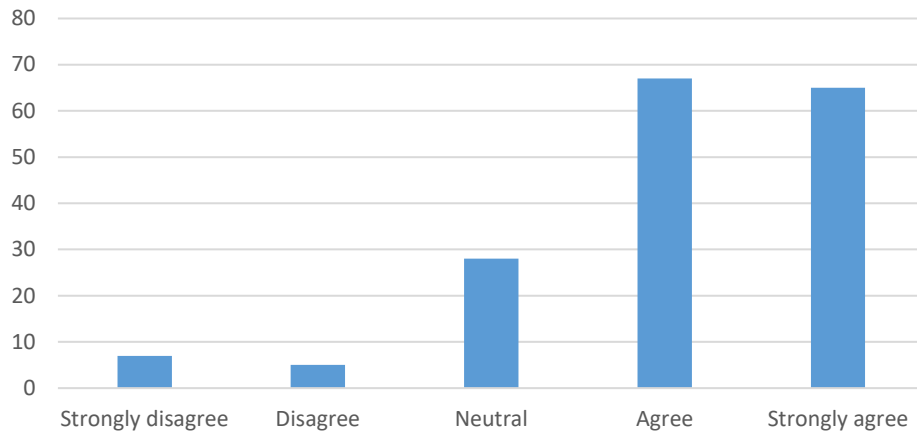

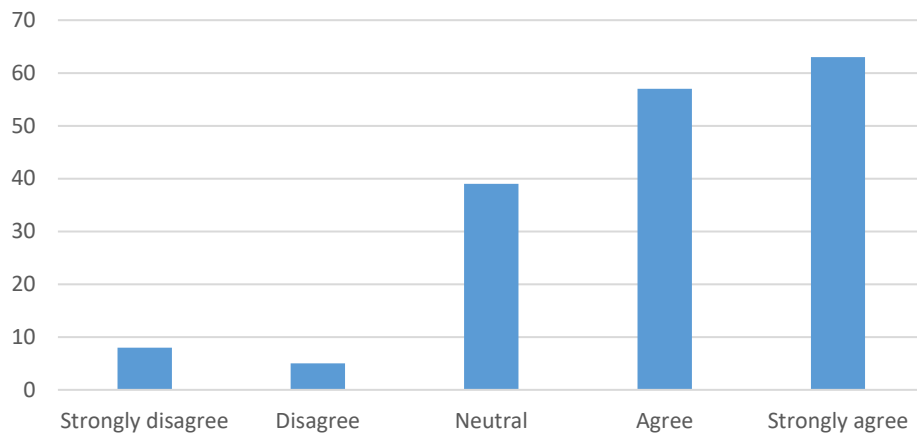

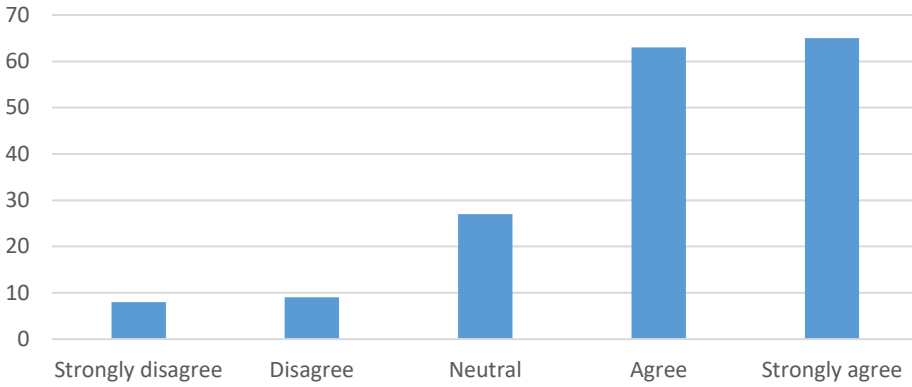

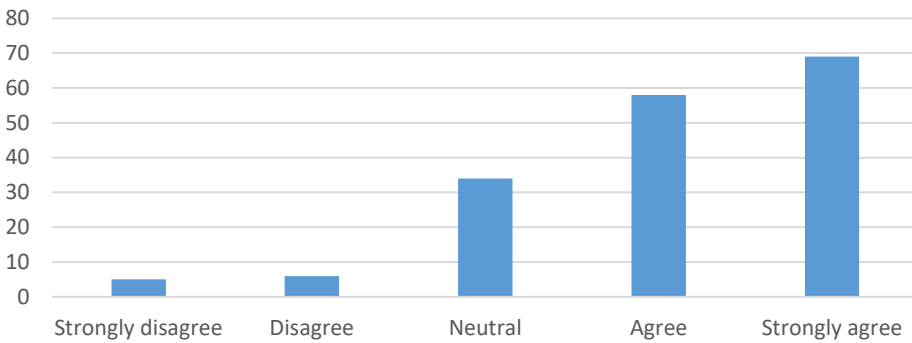

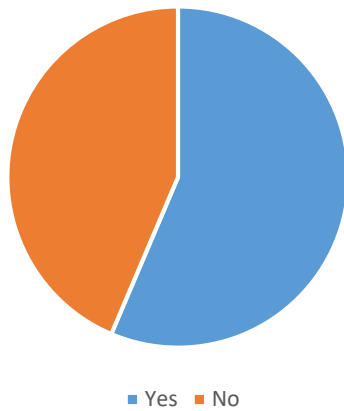


Student Perception on Education, Training and Support from Elmira Business Institute

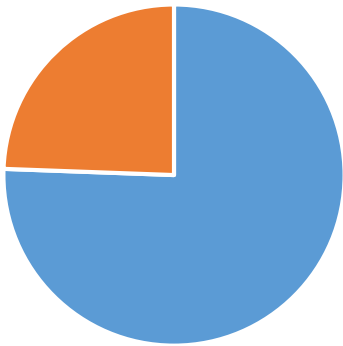
I am aware of who is EBI Career College's Title IX Coordinator

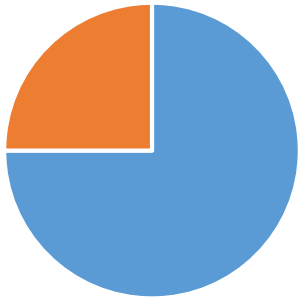


I know where to find EBI Career College's Sexual Misconduct Policy



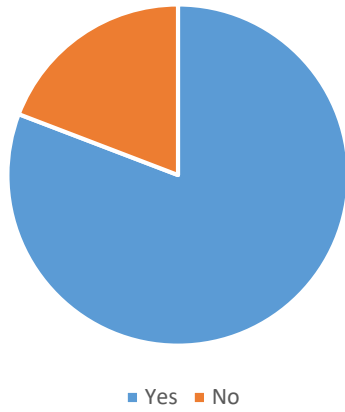

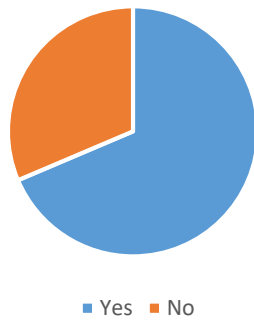

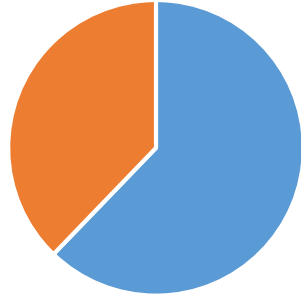

Do you feel EBI Career College has provided adequate educational programs around topics like sexual violence, dating/domestic violence and stalking?

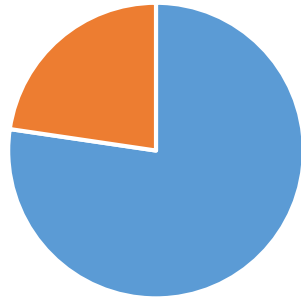


Do you feel EBI Career College provided adequate educational sessions on bystander intervention techniques?



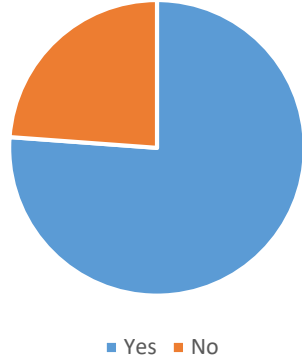

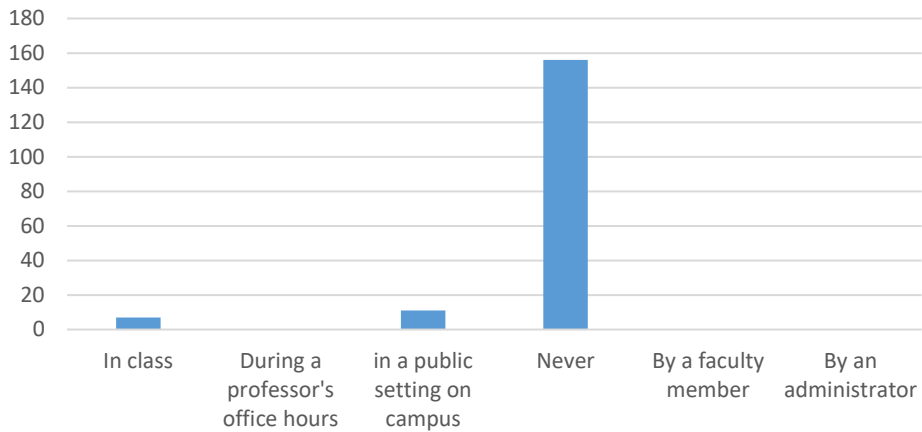

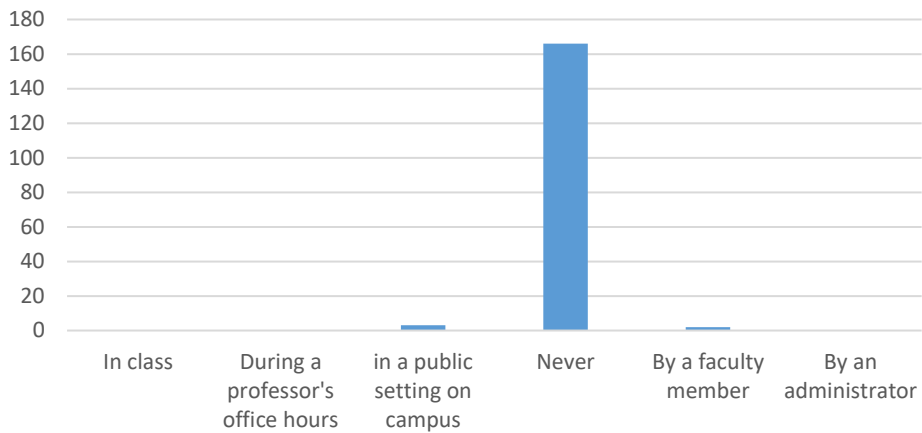
Student Incidents Since Enrolling at Elmira Business Institute



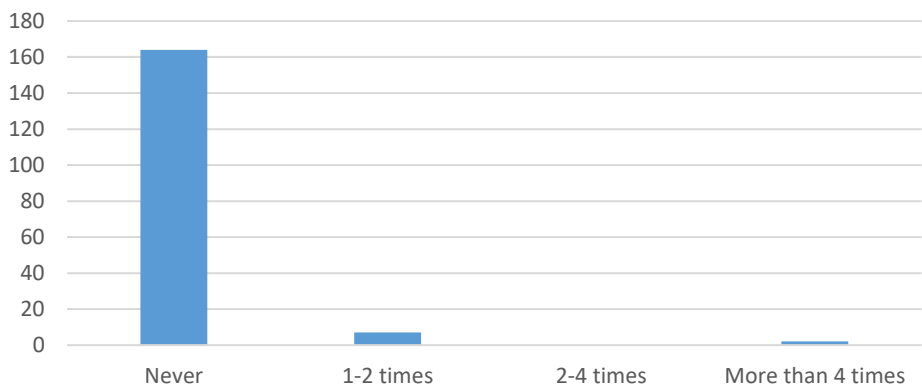

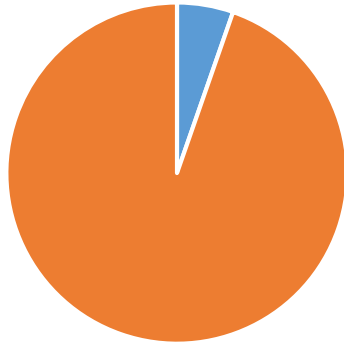
